Housing and Community Services Unit Colusa-Glenn-Trinity Counties

Many families experience short-term emergency situations. Safety net financial assistance enables families to bridge the gap to the achievement of long-term self sufficiency.

The Housing and Community Services Unit can assist with the following programs...

Utility Assistance, Wood, Propane, and Oil (HEAP) provides assistance to households in meeting their energy costs including propane/oil or wood vouchers. Assistance is also provided to households for repair or replacement of existing gas heating units which pose a health and safety threat. (Funding availability)

Special Needs assistance is provided through funding from the Sierra Health Foundation Grant. This program provides services for clients that are not covered under any other program (i.e. clothing vouchers, bus tickets for medical needs/job). (Funding availability)

Housing Choice Voucher Program (Section 8) provides subsidized rent assistance to individuals and families in order to provide access to safe affordable housing.



Homelessness Prevention and Rapid Re-Housing Program (HPRP) provides assistance to eligible individuals or families who are homeless or “at risk” of becoming homeless. Assistance may be in the form of security deposits, short and medium term rental assistance, and utility deposits. (Funding availability)

Homeless/Motel Vouchers are provided to homeless residents of Glenn and Colusa Counties for stays in a local motel. Trinity County provides homeless assistance through homeless shelters. (Depending on funding availability)

Family Self-Sufficiency (FSS) program is designed to assist families who are current Section 8 participants in developing employment, parenting, and life skills while becoming independent of all government aid over a five-year period.

Food Banks offer food for people in need as well as emergency food.

Independent Living Program (ILP) is designed to provide independent living skills training for youth preparing to leave foster care and for young adults who have emancipated. The goal of the ILP is to enable youth to achieve self-sufficiency prior to leaving the foster care support system and throughout the emancipation process. Services provided include assessments, basic-living education, vocational training, job seeking skills, and a Transitional Independent Living Plan.

Child Abuse Treatment (CHAT) Program funds direct services to child victims under the age of 18. Services included are therapeutic treatment to all child victims of abuse and neglect, abduction, domestic, family, school, and community violence regardless of race, ethnicity, or religion. CHAT advocates provide immediate and ongoing emotional support to clients as they work through loss, anger, sadness, and as they begin to reorganize their lives.

Victim/ Witness program is designed to assist people who have been victimized through violent crimes. Victim advocates assist victims and witnesses with their immediate safety needs, understanding the criminal justice system, financial, and emotional needs.
